"The room is recreated with exquisite attention to detail: a scribbled price list for sexual services on a whiteboard. A large bowl with condoms spilling onto the end table. Half-used lipstick scattered among twisted thongs, high heels and toilet paper. A sickly perfume-type smell that clings to the torn wallpaper. A grimy stained bed designed to shudder under the weight of invisible, moving bodies. Men's voices that alternately issue commands and groans. The room is part of an immersive art exhibit, "Journey," that depicts the experience of being a sex trafficking victim..."
